15. CHARLES⁵ IRISH (David⁴, John³, John², John¹) b in 1764. Res: LC. He was m 22 Mar 1787 in LC by Adam Simmons, Justice, to MARY BAILEY, dau of Cornelius and Mary (White) Bailey, b in 1768, d 1839

His will, recorded in LC Probate book 9, page 408, made 13 Apr 1840 and proved 17 June 1845; "To five daus Lucy Little, Hannah Thompson, Mary Irish, Abigail Irish and Nacy Irish my dwelling house, crib, back house and west garden and all household furniture. To son Isaac Irish my mahogany desk. To seven sons Tillinghast, David, Jabez, Isaac, Philip, Benjamin and Church and above daus all rest and residue. My son Isaac to be sole executor."

The will of Hannah Thompson recorded in LC book 10, page 614, made 12 May 1852 and proved 10 Jan 1853: "Hannah Thompson of LC single woman. To three sisters Mary Irish, Abby Irish and Nancy Irish all my real estate. To Lucy Little 30 dollars. To Orvin and Francis Irish 10 dollars. To sister Abby Irish my pleasure waggon and harness. To sister Nancy Irish all my chairs. To sister Mary Irish all rest and residue..."

17. JOHN⁵ IRISH (Samuel⁴, John³, John², John¹) b 14 Apr 1776 in LC, d there 24 Dec 1859. Res: LC. He was m 11 Jan 1795 by the Rev. Mase Shepard to NANCY LITTLE, dau of Fobes and Sarah (Wilcox) Little, b 20 Oct 1774 in LC, d there 23/27 Mar 1854. Both are buried in the old Commons cemetery. They lived on the old Irish place opposite the Friend's Meeting House.
